SOUTHEASTERN STAMP SHOW AND THE DEALER AGREE TO THE FOLLOWING:

1. SESS agrees to furnish the Dealer with Bourse space at SESS, to be held September 26-28, 2008 at the Cobb Civic Center, 548 South Marietta Parkway, Marietta, Georgia. Each booth will consist of two eight-foot tables (one sales table and one back-up table) and four chairs (three for customers, one for dealer).
2. Dealer agrees to pay SESS \$300 for a booth (or \$525 for a double booth). A non-refundable deposit of \$100 for a booth (or \$200 for a double booth) is required on or before June 1, 2008. The balance of the booth fee is due and payable 5:00 PM Friday, September 26, 2008.
3. Space is limited, **acceptance will be based on date of receipt of a dealer's deposit.**
4. Tables may not be shared, transferred, sold or sublet to another person or company. No extra sales tables will be allowed. Customers are not allowed behind the dealer's tables.
5. The Organizing Committee will take all reasonable and practical steps to insure the safety and careful treatment of materials during the exhibition. However, neither the Southeastern Stamp Show, nor any of its members, nor the Cobb Civic Center, nor any of its personnel shall be held responsible for any loss, theft, damage or injury that may occur before during or after the show to any contractor or his/her personnel.
6. Security will be supplied between 4PM Thursday, September 25 and 7PM Sunday, September 28. Access to the show area will not be allowed during non-show hours. Dealers are expected to insure themselves against loss.
7. Dealer agrees to sell philatelic related items and to identify any items that are counterfeit or that have been re-gummed, re-perforated, altered or repaired.
8. The Show Chairman shall have exclusive right to restrict the use of any audio and/or visual devices and to make final decisions regarding ethics, disagreements and other matters during the show.
9. Table assignments will be made based on receipt date of deposit (accompanied or preceded by signed Contract) and previous participation in SESS (and/or Peach State).
